

**Comparison of GSAs Formed Using 2003 Basin Boundaries vs. 2016 Basin Boundaries
Recommendation to Review GSA Boundaries and Update GSA Formation Notices¹**

The Department of Water Resources (DWR) has developed the SGMA Portal (<http://sgma.water.ca.gov/portal/#gsa>), which changes the manner in which local agencies are required to submit groundwater sustainability agency (GSA) formation notices. **Local agencies are now required to submit GSA formation notifications using the SGMA Portal.** The GSA notices included on the list below have all been submitted to DWR and are currently posted on DWR's GSA Formation Table (http://water.ca.gov/groundwater/sgm/gsa_table.cfm); each of these notices has been added to the SGMA Portal by DWR staff. For those notices uploaded by DWR, the posted information is included in Section B.4 of the agency's notice, while the GIS shapefiles reflecting initial GSA boundaries are included in Section D.4. All of this information can be downloaded directly from the SGMA Portal.

Many of the GSA boundaries previously submitted to DWR in 2015-2016 reflect GSA areas that were based on groundwater basin boundaries published in Bulletin 118 (2003) and may need to be revised to account for the 2016 basin boundary modifications. The GSA boundaries shown on DWR's GSA Interactive Map (http://water.ca.gov/groundwater/sgm/gsa_map.cfm) have also been added to the SGMA Portal and can be viewed on the *GSA Map Viewer*. The Exclusive GSA boundaries are now limited to the extent of the basins defined in Bulletin 118 (2016) and are consistent with the basins listed in the local agency's required resolution. A local agency may need to add a basin to its posted notice or upload new GIS shapefiles to account for new basin area. If new information is added to a posted notice, the local agency or GSA will need to resubmit that information to DWR, and will be required to make a determination if a material change to the posted notice has occurred.
