1. User Manual Purpose

This user manual documents the steps required to submit an Alternative Periodic Evaluation (previously referred to as 5-year updates) in the <u>Sustainable Groundwater Management Act</u> (<u>SGMA) Portal's</u> Alternative Reporting System.

The Alternative Periodic Evaluation module available on the Alternative Dashboard allows Alternative Agencies to submit Alternative Periodic Evaluations in the same format as Groundwater Sustainability Agencies (GSAs). Only users associated with an Alternative Agency may use the create, submit, and edit functions of the Periodic Evaluation module within the Alternative Reporting System. Users must have, and be logged into, a SGMA Portal account to view and use the Periodic Evaluation module discussed in this manual. The table of contents can be used to navigate to the desired section of this manual.

If you have questions regarding the Alternative Periodic Evaluation submittal process that are not addressed in this user manual, please contact the Department's Sustainable Groundwater Management Office at <u>GSPSubmittal@water.ca.gov</u>.

2. Alternative Dashboard

After a user logs in to the SGMA Portal, located at <u>https://sgma.water.ca.gov/portal/</u>, the user can select 'Alternatives' on the top navigation banner or click on the 'Alternative to GSP' button on the screen to navigate to the **Alternative Dashboard**.

The Alternative Dashboard is the Alternative Reporting System's centralized page for users to view and edit existing, or create and submit new Alternatives, Annual Reports, and Periodic Evaluations. The Alternatives, Annual Reports, and Periodic Evaluations listed on the Alternative Dashboard are dependent on the Alternative Agencies with which a user is associated.

1) Click the "Alternative to GSP" icon, the Alternative Dashboard window opens.






Figure 1. Screenshot of the SGMA Portal Homepage highlighting the "Alternative to GSP" icon.

2) The Alternative Dashboard includes modules for Alternatives, Annual Reports, and Periodic Evaluations. The My Alternatives list on the Alternative Dashboard (see Figure 2) is based on the Alternative Agencies with which a user is associated. Users may only create Periodic Evaluations for Alternatives for which they are associated. New Periodic Evaluations are created using the My Periodic Evaluations module on the Alternative Dashboard.

3. Create a New Periodic Evaluation

Only users associated with an Alternative Agency may use the create, submit, and edit functions of the Periodic Evaluation module within the Alternative Reporting System.



To create a new Periodic Evaluation submittal, the user should follow the steps outlined below.

1) Click the **"+NEW**" button on the top right side of the **"My Periodic Evaluations**" section of the **Alternative Dashboard**.

2) A window with Alternative Reporting Submittal instructions will open. Read the instructions and click the Close button. The Alternative Reporting Submittal instructions window closes by providing access to the Create Alternative Periodic Evaluation page.




Figure 4. A screenshot highlighting the "Pop-up Box" summarizing the Alternative Reporting Submittal process.



3) Fill in Field 1 on the Create Alternative Periodic Evaluation page by selecting the appropriate basin from the dropdown list for which the Periodic Evaluation is created. Note, only basins of Alternative Agencies with which a user is associated will appear in the drop-down menu.

4) Fill in Field 2 on the Create Alternative Periodic Evaluation page by selecting the appropriate Periodic Evaluation submittal number from the drop-down list. The first submittal number would be 1 and subsequent submittals would be numbered sequentially.

4. Alternative Reporting Submittal - Sections A through F

The Alternative Reporting System is designed to guide the user through each section, identified as A through F, in the left-hand column. Progress may be saved throughout the submission process, however, once the Alternative Periodic Evaluation is submitted to DWR, editing capabilities are no longer available.

4.1. Input Base Information (A)

After creating a new Alternative Periodic Evaluation submittal, the user will enter information for Step A - Base Information. Questions 1 through 3 will have been filled in from the information entered in the previous steps.

- 1) <u>Question 1:</u> This field is auto-filled based on the information provided at the time of creating the Periodic Evaluation.
- 2) <u>Question 2:</u> Choose a Plan Manager. The user can begin typing in the name of the Plan Manager and then select the correct name from the populated list of names in the system.
- 3) <u>Question 3:</u> Select all the Alternative Agency(s) within the basin that are associated with the development of this Alternative Periodic Evaluation.
- 4) <u>Question 4:</u> If applicable, you can upload a copy here of your 90-day notice that announces the planned adoption of the Alternative Periodic Evaluation and enter



the date that the notice was provided to each city and county within the plan area. Click "Upload" inside the box or drag and drop the file. This information is **optional**.

- 5) <u>Question 5:</u> If applicable, provide the date and a copy of the notice of the public hearing that was held when the Alternative Periodic Evaluation was adopted. This information is **optional**.
- 6) Click Save & Continue.

4.2. Adopted Alternative Periodic Evaluation (B)

User will now upload the adopted Periodic Evaluation in a single PDF file.

If the Alternative Periodic Evaluation needs to be provided in multiple files, contact DWR at GSPSubmittal@water.ca.gov for further instructions on how to submit multiple files.

- 1) Click in the box to browse to the Alternative Periodic Evaluation file or drag and drop the file into the designated space. The file size limit is <u>10 Gigabytes</u>.
- 2) Click Save & Continue.



4.3. Elements of the Plan (C)




Figure 9. Screen shot of the C Elements of the Plan page where the user decides whether to use the Elements Guide or Web Form.

If the user chooses to use the Excel Elements Guide, the user will then click Continue to Elements Guide.

The cells that are shaded grey do not require information and are not editable.

Page numbers must be entered as single pages (19), ranges separated by colons (19:28), or a mixture of pages and ranges separated by commas (19:28,33,56:68)

"N/A" is an acceptable entry for page number, but if that is entered, a comment must be provided in the notes to explain why the element is not applicable.

2) Insert pertinent information into the template. The Page Numbers of Plan column is the only required field. Section numbers, figure numbers, and table numbers are optional fields.

3) Upload the edited template by dropping it in the dotted box on the **Elements Guide** window. Please note that uploading the edited Excel template will overwrite any previous values that were entered in the Web Form under Elements Subarticle 1-5.

- 4) After uploading the edited template, a preview of the template will appear. Any errors will be marked with red text and an error message will appear stating in which Excel row the error(s) exist.
- 5) Make appropriate changes and re-upload the edited file. The user can not advance to the next step until the errors are fixed in the Excel template.

- 6) Click the **Upload** button.
- 7) After successful upload of edited Excel template, click on the **Continue button** on the Elements Guide page to move to the Web Form, which is the second method to provide the Periodic Evaluation information.

4.3.2. Using the Web Form

- 1) The Web Form is a replication of the Elements Guide (first method) into the web interface. The Web Form starts with the Periodic Evaluation by Agency page.
- 2) If the user uploaded an Elements Guide Excel file as instructed in Section 4.3.1, the required information in the Web Form fields will already be populated. Otherwise, follow step 3 below.
- 3) Fill in every Page No. field where each regulation element can be found within your Alternative Periodic Evaluation document. If applicable, the Alternative Agency may also provide corresponding section numbers, table numbers, and/or figure numbers to further clarify where the Periodic Evaluation addresses elements of the GSP Regulations.
- Page numbers must be entered as single pages (19), ranges separated by colon (19:28), or a combination of pages and ranges separated by commas (19:28, 33, 37:42).



5) "N/A" is an acceptable entry for page number. However, an explanation for Not Applicable should be provided in the notes section.




Figure 15. Screen shot of the top portion of the Web Form first section "Periodic Evaluation by Agency".




Figure 18. Screen shot of the Supporting Information Window.




Figure 21. Screen shot of the E References window.




Figure 22. Screen shot of E References window showing where to click to add a reference.




Figure 23. Screen shot of New Reference data entry window.





Figure 24. Screen shot of the E References window showing where to click to import references.

To submit your Alternative Periodic Evaluation and complete the submittal, go to the **F Plan Submittal** tab.






Figure 27. Screen shot of Alternative Periodic Evaluation Submittal page.

- Read the message and ensure you have completed all the requirements for the Alternative Periodic Evaluation submittal. Check the box, "I have reviewed the information entered and I'm ready to submit. I understand that once I hit submit, I can no longer make changes."

If there are required parts of your submittal that the system detects have not been completed or are erroneous, an error message will appear and return you to the submittal.






Figure 28. Screen shot of Error(s) popup telling the user there is missing or erroneous information.
